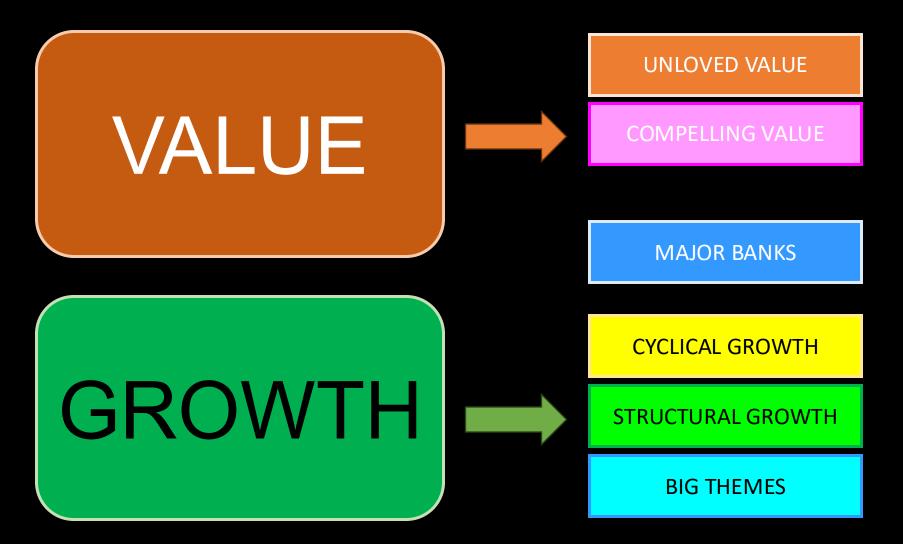

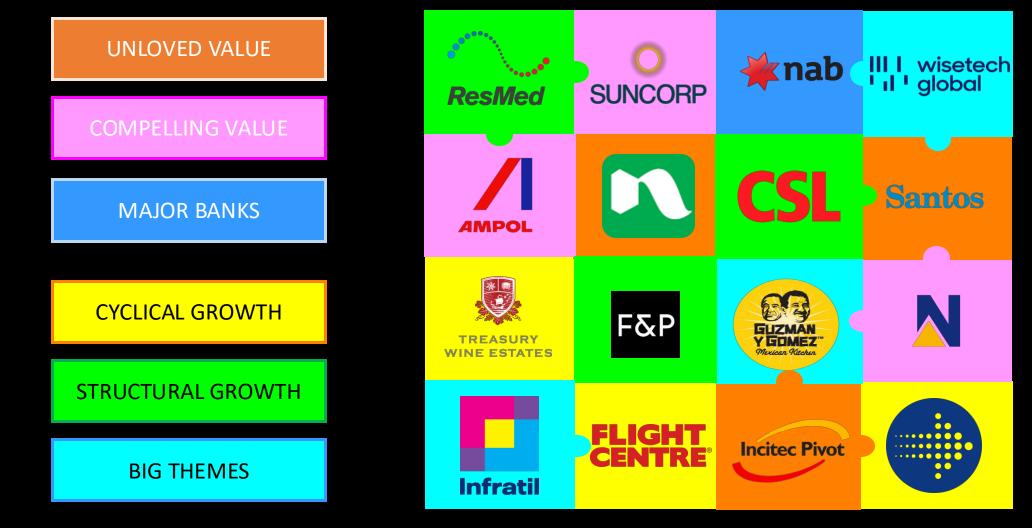

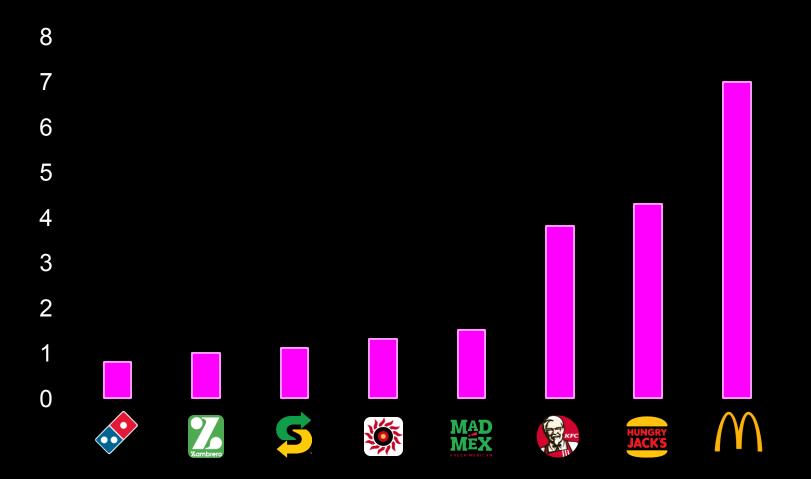

Revenue per (Drive-Thru) store (A \$m)



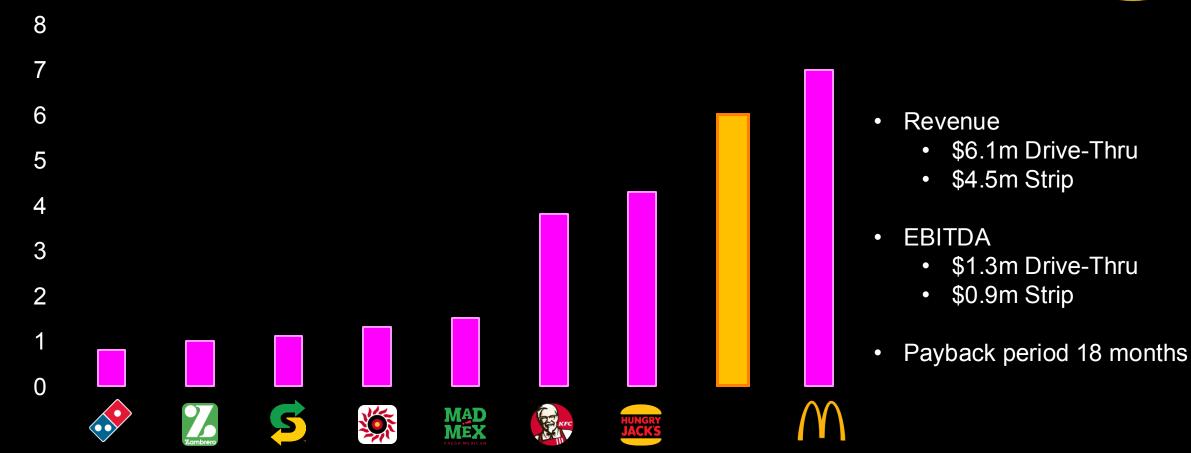

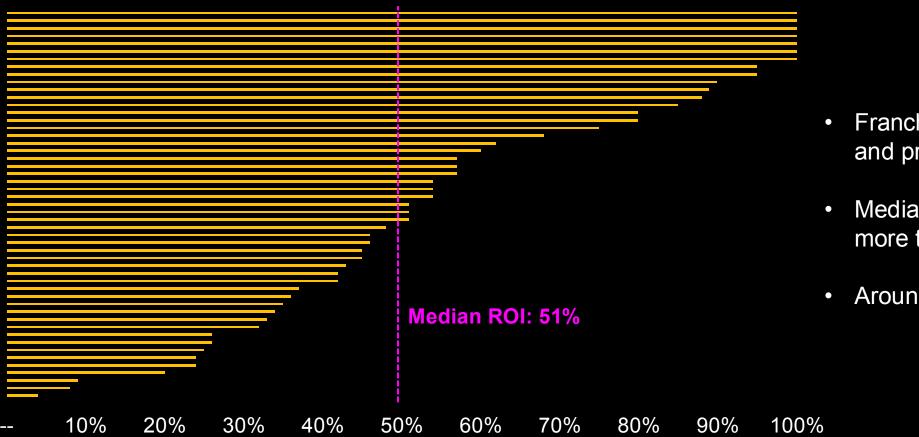

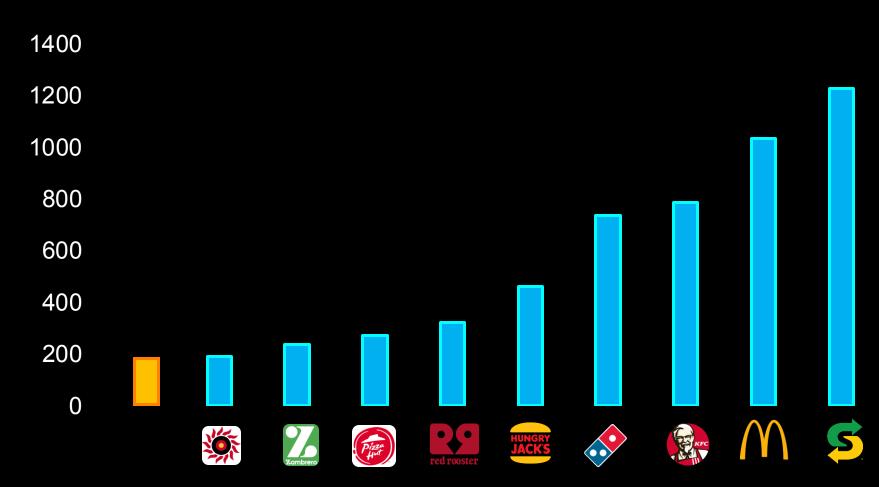

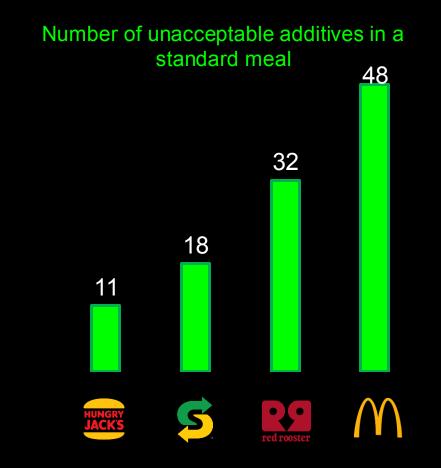
